SECRETARY'S REPORT:.

I would like to thank the President, Craig and Mike Cannon for their assistance in composing the letter to Mrs Robyn Parker, NSW Minister for Environment & Heritage re the Licensing review. The letter requested an appointment to discuss Licensing as this has not been reviewed for 4 years. There are some species, namely, Double Bar Finch, King Parrot and Turquoise parrot which need to be removed from License as they are the most licensed birds in NSW and in abundance in aviaries and the wild

On 13th May President, Craig and I travelled to Wollongong, where Mike Cannon tried to reprint the "Communicator", but was not successful. Since then have contacted an I.T. specialist who is currently working on making the document editable and setting up a template for future editions. Hopefully, the "Communicator will be ready for distribution in July with the nomination forms and Agenda for the Annual General Meeting in August 2012.

To date have received 2012-2013 membership renewals from 29 clubs with insurance, 3 clubs -no insurance and 12 individuals Also 2 New clubs with Insurance

PUBLICITY REPORT

The Secretary reported on Fairfield Bird Sale, The ABA sign was not successful as it collapsed. Handed out 30 flyers and complimented the organiser on a very well run sale. In reference to Mornington Bird Sale the President said it was very good and well conducted. A few issues with local council were discussed and all seems to be okay now.

Chris suggested a representative from the ABA should go to some clubs in Victoria to promote and respond to questions regarding the ABA.. Mike thought getting the Newsletter up and running would be the best start to promotion.

Following an enquiry from Chris the ABA will be approaching more Bird Shops re membership in the new financial year.

Chris still waiting for ABA sign for shop. Chris mentioned 'Animal Welfare are satisfied with alterations to his bird park which comply with the standards

GENERAL BUSINESS:

Insurance Policy - It was decided to change the ABA Liability Insurance from GIO to CGU as CGU is more competitive and 'user friendly' in regards to bird sales and shows. The new policy to commence on 1st July 2012. The cost to ABA member clubs will remain at \$100 for the year 2012-2013. This amount will be reviewed for 2013 -2014 membership year to consider lowering the Insurance cost to clubs. It was decided the payment to CGU be made up front rather than in monthly instalments to reduce the cost..

A show of hands indicated acceptance of the above.

Please Note: The Insurance policy only covers the Club named on the Currency Certificate

<u>Mail Outs</u>: The Secretary has been looking into the quickest and most economical way to send information to members (approximately 50%) who do not have email addresses, Australia Post has given the ABA Post Print approval for mail outs. Post Print involves buying sealer and plastic pouches, but it the overall cost is still considerably lower.

<u>Far Nth Cst Bird Breeders</u> - Two emails were tabled from Barbara Devnie regarding a defamatory report about the ABA, published in the Far Nth Qld Bird Breeders Newsletter by John Griffiths. President Craig has since spoken with John Griffith regarding this and requested contact details and telephone number of the Mayor of Cairns Regional Council. A letter of support has been sent. Mike suggested we write to the Far North Coast Bird Breeders to clarify the situation and if possible do whatever we can to assist them .

<u>Pigeon Virus</u> - Two emails received today from George Arzey DPI NSW were read and discussed. Mike Cannon has been talking to the Dept Primary Industries and it doesn't concern flying Pigeons ,it is about the fancy pigeons, except in Melbourne, and it was stopped to the best of their ability. In the United Kingdom the vaccinate each year using the chicken injection and get about 90% success rate.

National Parks and Wildlife contacted the ABA, regarding two *Major M*itchells being held by WIRES at June, and requested names of bird keepers in this area to try and re home them.. There are too many for Zoos, Animal Parks etc and they were seeking an alternative to euthanizing them.

WIRES - Rod spoke about a flight aviary recently built by WIRES in the Southern highlands

Mike suggested we canvas ideas to get maximum membership attendance at meetings.
